KACA Session at AEJMC in Chicago

-Mass Communication and Development in Korea

Renowned Korean scholars delivered their enthusiastic presentations on variety of topics on the current development of Korean mass communication and advertising fields during an annual KACA session for AEJMC.

The presentation stood out from the rest because the paper topics evenly represented relevant issues for both younger and old generation in Korea.

Moderated by Jong K. Kang of Illinois State, the KACA session presenters explored essential issues, such as "Anti-Journalistic Problems of Korean News Media" by Hyo-Seong Lee from Sung Kyun Kwan University in Seoul, Korea.

Professor Lee defined Korean new media today seem to be far away from democratic and mature journalism in spite of remarkable growth in terms of the amount of assets and revenue.

Kwangmi Ko Kim of Appalachian State University presented alarming report entitled: "Conflict Between U.S. Domestic and Foreign Policy on Cigarette Promotion: A Historical Analysis of U.S. Promotion to Asian Countries." Her research critically examined how contradictory the U.S. policy is on the issue of opening Asian cigarette markets.

She claimed the U.S, government totally ignored the health aspect of cigarette export and handled it as a simple trade issue.

Seok Kang and Jong K. Kang of Illinois State examined the issue of "Television and Value Perceptions Among Korean College Students" while Seong Hyung Lee of Appalachian State University and Dong Hyun Byun of Chonnam National University compared Korean and American journalists' perceptions of North Korea in their paper "Comparative Study of Korean and U.S. Broadcast Journalist: Perceptions of North Korea"

Ki-soon Park of Sung Kyun Kwan University offered insightful critiques and suggestions as a discussant.

Dinner Reception

The annual convention dinner reception was attended by more than thirty Korean faculty and students at Woo Rae Oak Restaurant which was only a few blocks away from the conference site (see photo from the reception). During the dinner, new KACA members were warmly welcomed by existing members and staff.

In addition, many KACA members expressed great interest and offer their constructive suggestions regarding a plan to host ICA conference in Seoul 2002.




